

As we bring you this Annual Report, we are also reflecting on our mission and the incredible impact we have made on the lives of those we serve. We are proud of our ongoing commitment to the healing power of art and community. As you read on, you will see that 2022 was an exciting year full of transitions and impactful outcomes for our We Care Arts community. Throughout the year, we were focused on creating meaningful programming that served our artist-clients. We are proud to report that over 2,400 hours of programming was delivered both in-person and virtually. This programming and the artistry of our artist-clients led to nearly 1,800 pieces of artwork being inventoried for sale on-line and at our gift shops at the Berkeley Center campus and at the Town & Country shopping center. During the year, nearly 2 out of every 3 works of art were sold, which is a testament to the effectiveness of our programming, the talent of our instructors, and the quality of the work being produced by our artist-clients!

An exciting update is that we have seen the return of volunteers to the building after COVID-19. Their assistance has been a huge help in delivering our programs and services. We are so grateful for their support and look forward to continuing to work with them in the future as we begin to build back our onsite volunteering program.

Who We Serve

We Care Arts is an organization that strives to promote healing through art and community. Terry Schalnat founded the organization 39 years ago with the aim of supporting individuals in the Dayton area who were facing challenges due to massive layoffs. With previous experience working with women in Appalachia, Terry had seen firsthand how art could positively impact an individual's wellbeing. She began her work with Lutheran Social Services in a Lutheran church's basement, with the goal of making a difference.

Today, We Care Arts has grown. We now occupy a 10,000 square foot building and maintain two gift shops serving hundreds of artist-clients, their loved ones, and support teams across the Greater Miami Valley. The artist-clients are adults who are living with developmental disabilities, addiction, and mental health issues. We welcome all individuals from diverse backgrounds, no matter their gender, ethnicity, religious affiliation, sexual orientation, income level, or artistic ability. As we have evolved over the years, We Care Arts remains committed to nurturing the creative spirit of those we serve and foster a culture of inclusivity and expression as we work together to bring our mission focused on art and community to life each and every day.



Strategic Plan Updates

Our organization has been executing its strategic plan effectively by focusing on several key areas. Firstly, we

are working towards building a new generation of donors while also reengaging former donors. This involves implementing creative fundraising strategies and leveraging new technologies to connect with younger audiences. Secondly, we are committed to staff growth and empowerment, which includes providing training and certifications, professional development opportunities, fostering a positive work environment, and promoting diversity and inclusion. Thirdly, we are continuously enhancing the artist-client experience by improving our services and tailoring them to meet the evolving needs of our community. Lastly, we are focused on the growth and engagement of our volunteer and partner network, which plays a critical role in helping us achieve our mission. We are dedicated to building strong, collaborative relationships

with our partners and volunteers to maximize our impact and reach.

We Care Arts recently underwent a significant restructuring to better reflect a hierarchical structure under the guidance of our new Executive Director.

As part of this reorganization, a new Director of Programming was brought on board in the fourth quarter of 2022 to oversee and coordinate all programming

activities. To further clarify departmental responsibilities and streamline operations, new roles were created within each department, including new managerial positions and support staff. These changes have been implemented to ensure greater efficiency and accountability throughout the organization, with the goal of delivering better services to our artist-clients and stakeholders.

Our team has also been focused on strategically enhancing our facility to improve accessibility. In 2022 plans were started for updating all entrances to our Berkeley Center Campus. This included planning for and identifying funding opportunities for the construction of a ramp and the installation of an automatic opening door out the South Side of our building in Zone 2, as well

as our front door and our Main Zone 1 door off of our parking lot. With the planning completed in 2022, 2023 will see We Care Arts writing grants and seeking funders to underwrite the cost of these accessibility and safety focused upgrades which will result in a more inclusive and welcoming environment for all.

VISITING ARTIST – PEACE MUSEUM AND METRO PARKS

The class is open to all artist-clients enrolled in the program and occurs outside of ordinary class times. One of the 2022 Visiting Artist sessions was taught by a museum representative from the International Peace Museum for a project called the "Peace Pole." 


IST ANNUAL TRUNK OR TREAT


ART ON THE LAWN - YELLOW SPRINGS, OH






